	system as used at the Tough Mudder Event, which has been successful in minimizing the quantities wastes sent to landfill generated front of house.
	In back of house areas i.e. catering there will be allocated 240ltr bins for generated waste and 1100 litre bins for cardboard which will be clearly labelled. There will also be 240 litre bins for comingled recycling. The cleaning manager will liaise with catering and food stall holders and monitor wastes in these areas to ensure waste streams are not contaminated.
	Collection of FOH, BOH, Waste Stations and nominated areas will continually be cleared and transported to dedicated holding skips. There will be sufficient volume in these skips to contain the waste generated for the duration of the event.
	Manure will be transported and stored in a sealed underground tank. Collection of equestrian effluent waste will occur on a weekly basis and increase over known equestrian event times by a liquid waste contractor. The solid materials will be sold and transported to local growers and the overflow taken to green compost facilities.
	Bulk waste skips will be transported by the contracted waste supplier and taken to the closest sorting facility and land fill site respectively. Post events we will detail litter pick the site to ensure no waste is left onsite. On completion of the larger events a detailed waste report will be provided stating the weights of each waste stream and % of total waste. Recommendations for improvements or changes will be made at this time for the following year's event.
