MAINTENANCE ACTION	FREQUENCY	RESPONSIBILITY	PROCEDURE
Remove blockages from grass treatment area.	As Required	Maintenance Contractor	Remove any sediment/trash from the grass treatment area of the bio-filtration swale.
Inspect for standing water.	As Required	Maintenance Contractor	Ensure swale is free of blockages, is level and drains freely towards outlet.
Inspect vegetation	As Required	Maintenance Contractor	If grass is sparse, plugs of grass from the upper slopes are to be replanted at the base of the swale into loosened, fertile soil.
Maintain Vegetation Height	As Required	Maintenance Contractor	If vegetation exceeds a height of 0.2m, carefully mow to no less than 0.1m height. Grass clippings are to be removed.
Inspect inlet/outlet	As Required	Maintenance Contractor	Screens of inlet pits in swale ARE to be checked for blockages and debris REMOVED.
