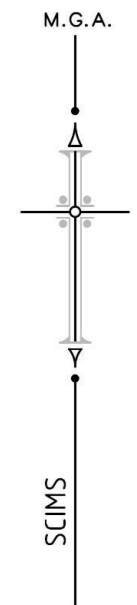
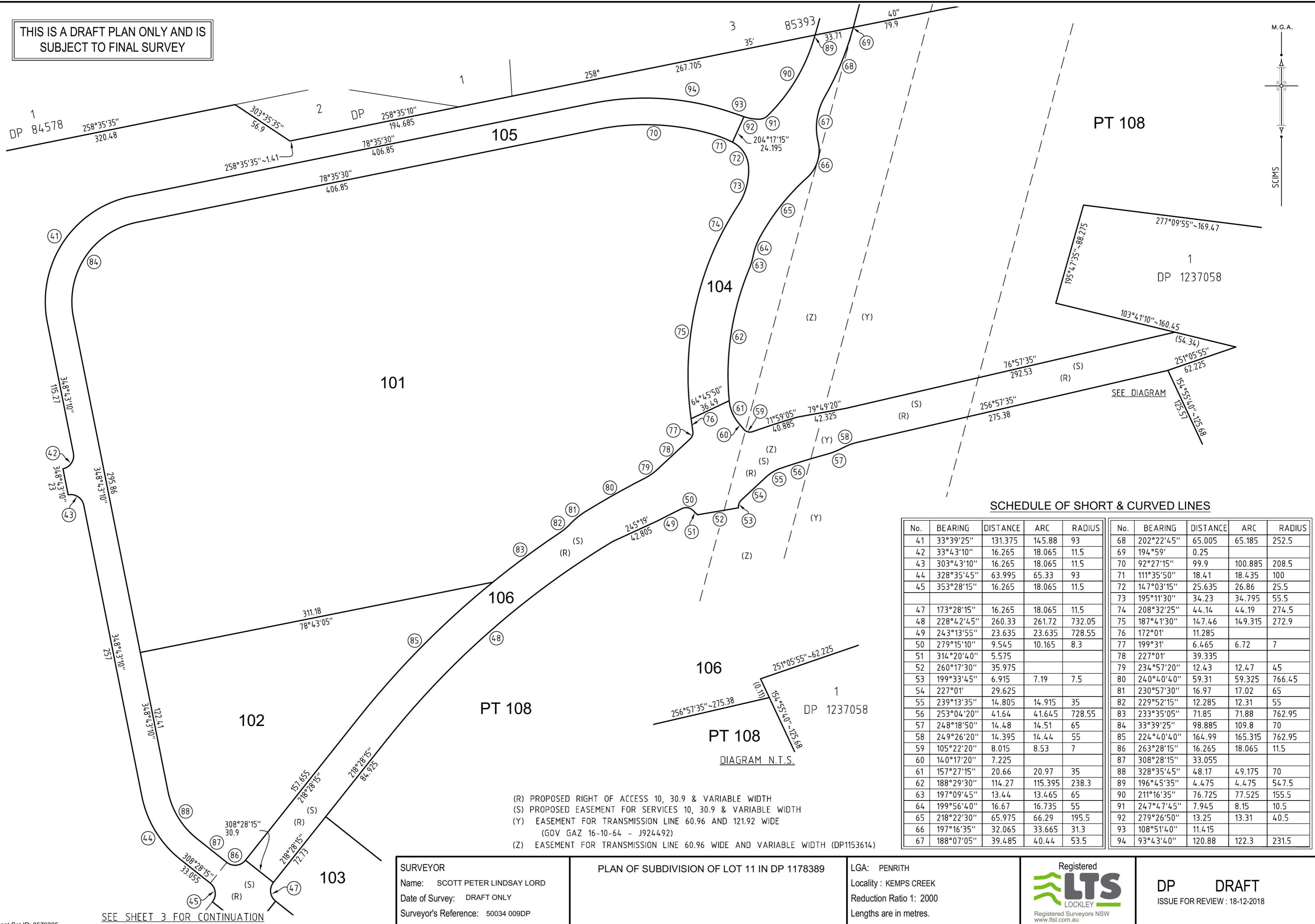
PLAN OF SUBDIVISION OF LOT 11 IN DP 1178389

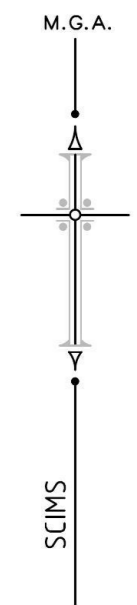
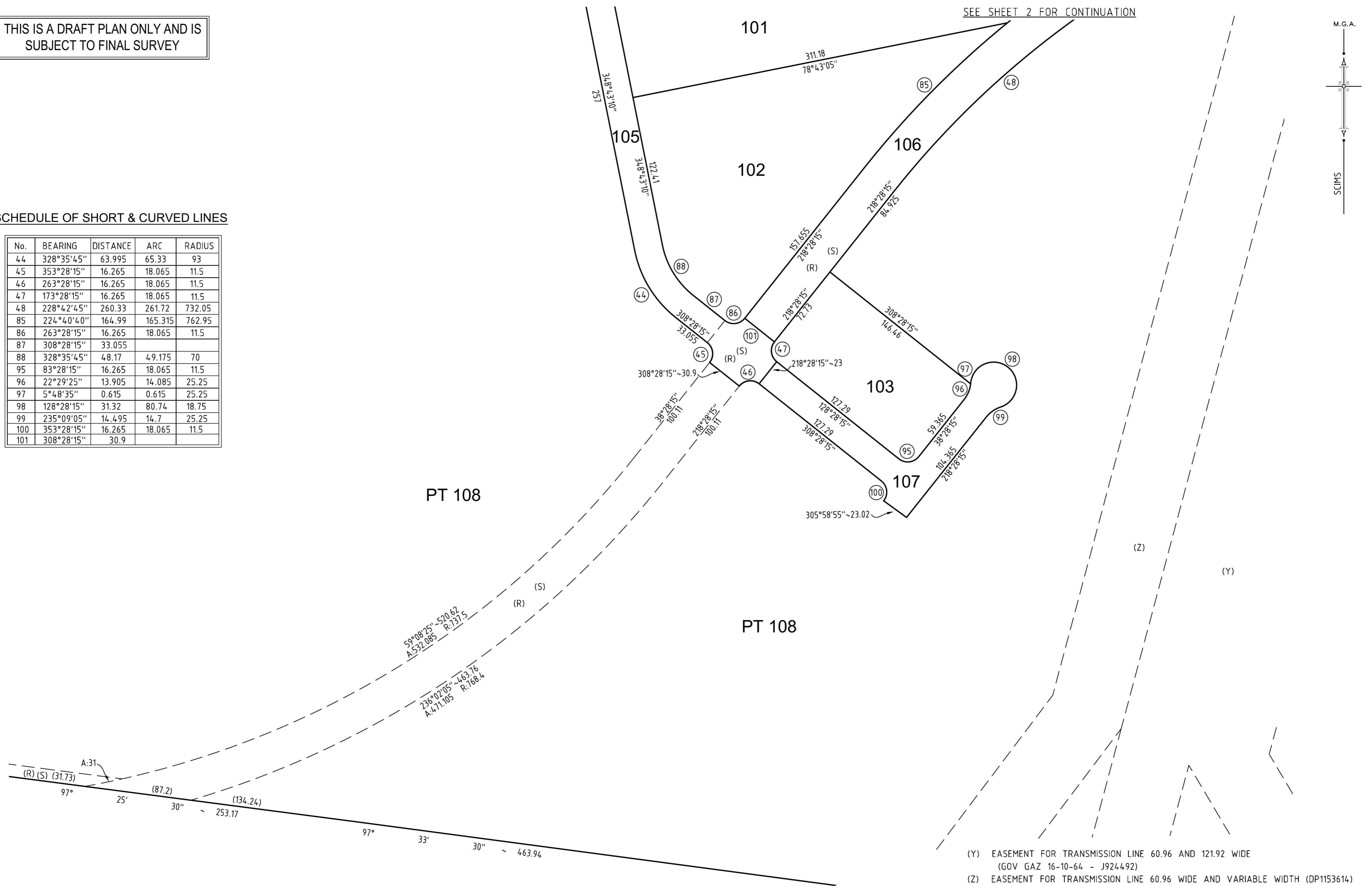
