**Fernhill Estate
Car parking Allowance - Masterplan DA**

GHD has prepared this letter in regards to the requirement for consideration of heritage impacts associated with parking at the Fernhill site. This is due to the potential impacts on grasslands and the capacity of land to accommodate agricultural landuse, particularly grazing, following event parking in the Western Precinct.

In order to address these concerns, GHD will undertake a study of the Fernhill site and develop an Environmental Management Plan (EMP). The EMP will investigate potential issues associated with soil compaction, loss of groundcover, contingency plans to be actioned in the event of wet weather and mitigation measures to avoid long term impacts on vegetation and site heritage value. It is intended that the EMP will be based on the following framework:

1. Confirm the areas identified for parking
2. Describe the regularity of the parking
3. Brief site analysis and description of the ecology of the areas/paddocks subject of parking
4. Describe the potential impacts of parking
 - Compaction
 - Contamination
 - Wet Weather / different weather conditions
 - Impacts on agricultural uses
 - Scenic / heritage impacts
5. Describe mitigation and management measures including
 - General management including use of signage, avoidance and protection of ecological areas
 - Rotation of areas used for regular parking
 - Wet weather management

- Treatment of paddocks after major events

6. Conclusion and recommendations

The EMP is to be completed, subject to agreement with the proposed framework, in the first quarter of 2014.

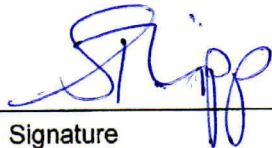
