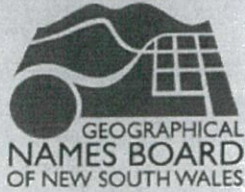

ROAD, HARTLAND ROAD, SONATA WAY, SUNBURST DRIVE, GARNET DRIVE,  
PYRUS LANE, AVIUM CIRCUIT, CARICA ROAD, STARLINE DRIVE,  
MIDNIGHT AVENUE, DELAWARE AVENUE

On behalf of the Surveyor General (SG) the names have been reviewed under the Geographical Names Board's NSW Addressing User Manual and the following objections have been raised:

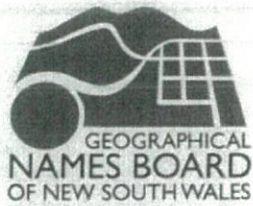
**WOODLET TERRACE** – objection is raised under Principle 6.7.4 *Uniqueness, Duplication* of the NSW Addressing User Manual. There is a **WOODLAND AVENUE** located in Oxley Park.

**HAMLIN STREET** – objection is raised under Principle 6.7.4 *Uniqueness, Duplication* of the NSW Addressing User Manual. There is a **HANLON STREET** located in Cranebrook. X

**PYRUS LANE** - objection is raised under Principle 6.7.4 *Uniqueness, Duplication* of the NSW Addressing User Manual. There is a **PYRAMUS PLACE** located in St Clair.

Should you wish to proceed with adoption of the names to which objections have been raised, then Council should write to the **Secretary of the Geographical Names Board, NSW Spatial Services, Bathurst, PO Box 143, NSW 2795** setting out reasons why the name is valid. The matter will then be put to the Board who may choose to overturn the objection.
