All waste will be separated and stored in bins or specified stockpiles that will be located on the site during construction and site access will be established.

How will site operations be managed to ensure minimal waste creation and maximum reuse and recycling?

All sub-contractors will be required to adhere to safe work practices and conditions addressing matters such as Staff training, recycled materials used in construction, waste management requirements stipulated in contracts, on-going checks by site supervisor, separate area set aside for sorted wastes, and clear signage of waste areas etc. Additionally it is considered that this issue can also be addressed by appropriate conditions of development consent.

SECTION FOUR – ON-GOING MANAGEMENT OF PREMISES

Attached to this submission is a detail plan of the proposed Goods Receiving area for on-going use. (refer Appendix 9 of Statement of Environmental Effects)

This detail identifies the location for the cardboard and plastic bales, and timber pallets, pending their collection.

It also identifies the proposed location for the general waste bins.

Please note that these bins include lids which keep them covered and free from animals.

Given Bunnings do not have significant perishable waste streams, it is Bunnings' experience that these bins are entirely adequate for their purpose and do not require special housing nor specific bunded wash out facilities.

These waste management practices are in line with the current practices used at the existing Bunnings on this site and at other Bunnings elsewhere.
