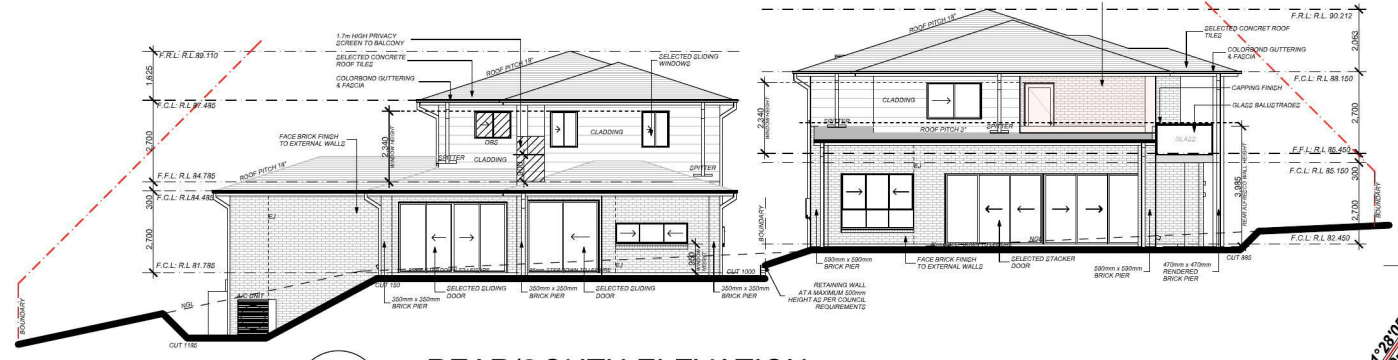

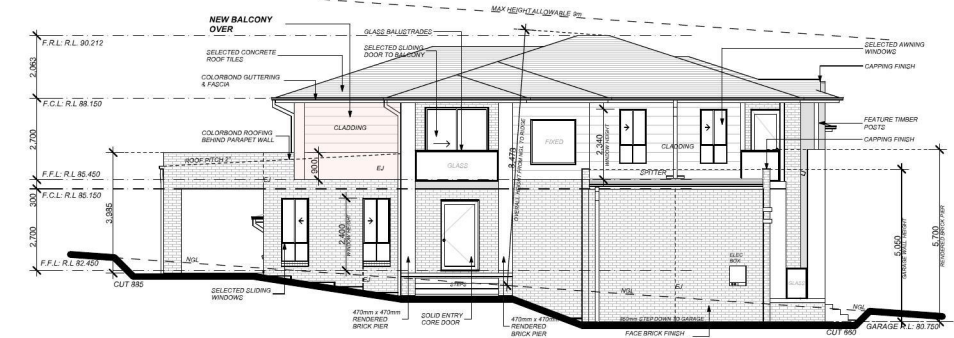
RIGHT/WEST ELEVATION

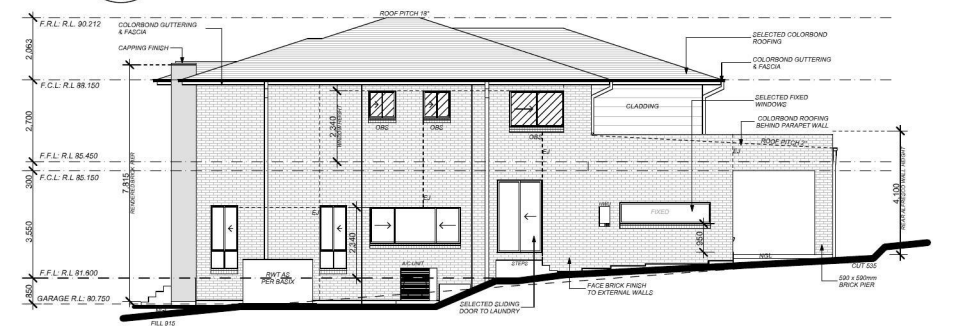
REAR/SOUTH ELEVATION

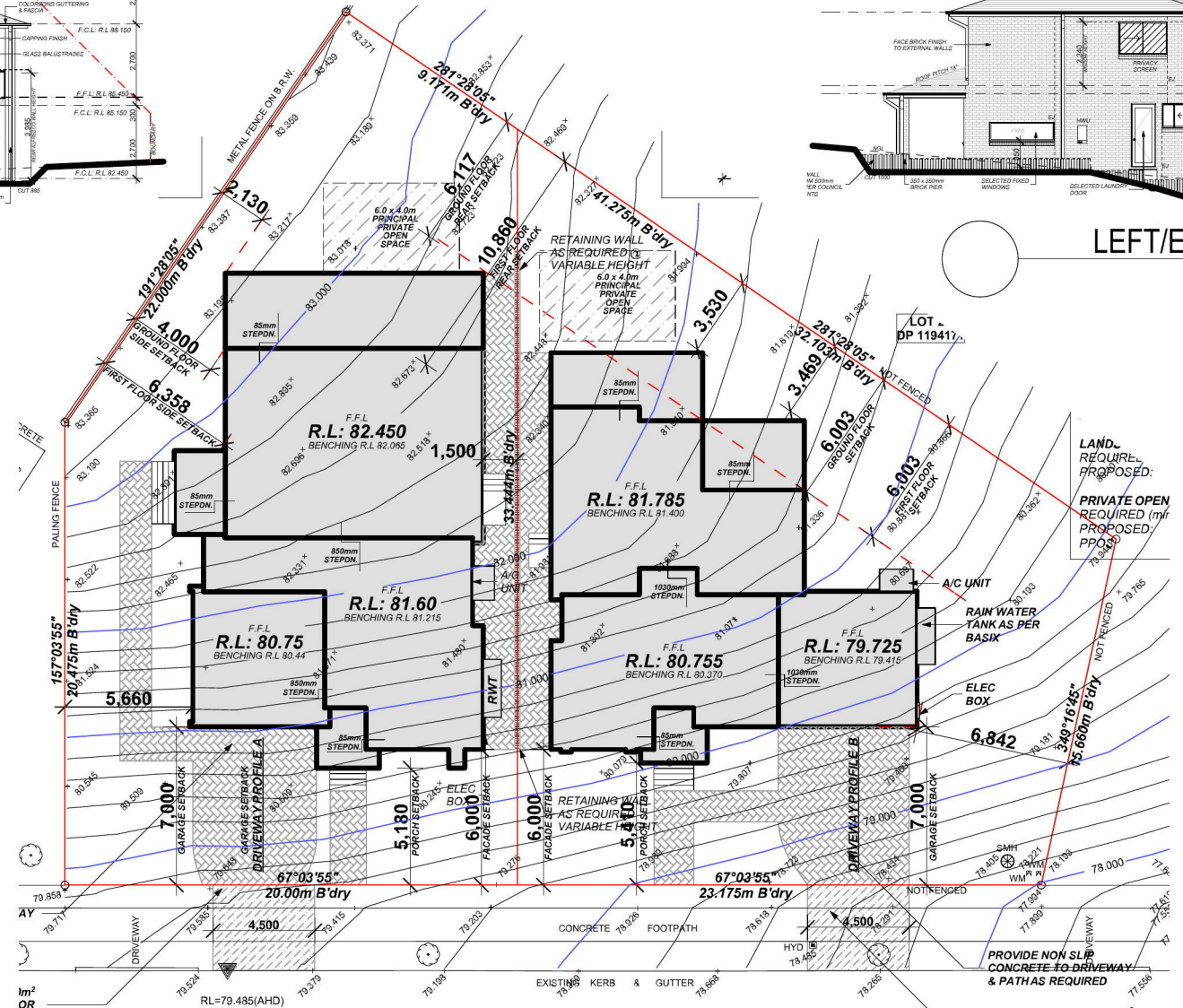

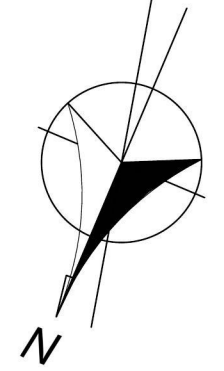
