#### **Fencing**

All rides are totally enclosed with fencing to Workcover standards.

#### **Workcover**

Every Ride is registered with Workcover and have operational manuals with Safe Work Method statements. Council can arrange to view them by contacting our office on 9897 1041. All staff are trained in the operation of our Amusement devices.

#### **Side Show Alley**

No Side Show games involve the use of water or generate any water waste.

#### **Temporary Structures.**

There will be no temporary structures.

#### **Main Power Requirements**

We will not require any power as we will be using our own generators (indicated on the site plan)

#### **Public Address System.**

There will not be any PA systems or amplified music during the event.

#### **Fireworks**

There will not be any fireworks at the event.

#### **Toilet facilities**

We will be providing toilet facilities at the event. We propose 2 male and 2 female toilets. Coates Hire will provide the toilets, replace if necessary, and clean daily. The toilets will be inspected by the Manager (John Phelan) each night to determine if any toilets need replacing. The toilets will be cleaned and replenished each morning by 10am.

#### **Waste Management**

We will 10 supply bins and do not require any additional bins during the event and no extra street cleaning will be required. Our waste collection area is indicated on the site plan. Phillips Waste Bins will remove the waste from the site. The site will be left in the original condition in which we will find it.
