ACCESS AND EGRESS

ACESS AND EGRESS TO AND FROM SITE WILL BE FROM ONE DRIVEWAY AS MARKED ON ATTACHED PLAN WITH A MINIMUM WIDTH OF $6.2\ m$ AND CLEARLY MARKED WITH ENTRY/EXIT SIGNS.

IMPACT ON AREA
